To Our Residents and Family Members:

In our ongoing communication with you during the COVID-19 pandemic, **Warsaw Nursing and Rehab Center** continues to issue communication regarding the status of our residents and employees. On October 19, 2020, we received confirmation that one employee tested positive for COVID-19 at a local provider. The employee has been removed from work and will be self-quarantining for the next 14 days. Two negative testing results will be required prior to returning to work. Additionally, two residents tested positive for COVID-19 after developing symptoms and undergoing rapid testing. Our team at **Warsaw Nursing and Rehab Center** remain committed to the quality and safe care of our residents. **Warsaw Nursing and Rehab Center will be postponing all visitation, scheduled to start on October 13, 2020, until further notice.** We will continue to provide updates as additional information becomes available.

The safety and wellbeing of our residents continues to be our top priority. We are doing everything we can to limit the spread of COVID-19 within **Warsaw Nursing and Rehab Center**, including staying in very close communication with local and state health officials to ensure we are taking all the appropriate steps under current circumstances.

We are taking steps based on guidance from the Centers for Disease Control and Prevention (CDC) and the Center for Medicare and Medicaid Services (CMS) to reduce the spread and impact of COVID-19, such as:

- Enhanced infection control precautions
- Screening residents, staff, and essential visitors for expanded list of symptoms
- Restricting visitation and entry of people to the building
- Proactively testing staff and residents for COVID-19 based on current protocols
- Postponing communal activities
- Increasing PPE par levels
- And CDC/CMS recommendations

We also understand that connecting with family members is incredibly important to our residents. Additionally, we encourage family members to connect with their loved ones through video chat, calling or facetime. We can also arrange for window visits.
