To Our Residents and Family Members:

In our ongoing communication with you during the COVID-19 pandemic, **Bland Nursing and Rehab Center** continues to issue communication regarding the status of our residents and employees. **Bland Nursing and Rehab Center** continues to test all employees and residents for COVID-19 per CMS testing recommendations, and to help guide our decisions during the pandemic. On March 17, 2021, **Bland Nursing and Rehab Center** received confirmation that one employee tested positive for COVID-19. This employee has been removed from work and will be quarantining for 14 days. Prior to returning work, a negative PCR test will be required. **Zero** residents tested positive for COVID-19. We continue to promote social distancing inside and outside of work and encourage all citizens to practice social distancing due to the direct correlation between community spread and facility spread. Bland County currently has a COVID infection positivity rate of 2.10%. **Our team at Bland Nursing and Rehab Center remain committed to the quality and safe care of our residents. Bland Nursing and Rehab** will continue testing once weekly. We will continue to provide updates as additional information is available.

The safety and wellbeing of our residents continues to be our top priority. We are doing everything we can to prevent the spread of COVID-19 within **Bland Nursing and Rehab Center**, including staying in very close communication with local and state health officials to ensure we are taking all the appropriate steps under current circumstances.

We are taking steps based on guidance from the Centers for Disease Control and Prevention (CDC) and the Center for Medicare and Medicaid Services (CMS) to reduce the spread and impact of COVID-19, such as:

- Enhanced infection control precautions
- Screening residents, staff, and essential visitors for expanded list of symptoms
- Restricting visitation and entry of people to the building
- Proactively testing staff and residents for COVID-19 based on current protocols
- Postponing communal activities
- Increasing PPE par levels
- And CDC/CMS recommendations

Due to government privacy requirements, we cannot divulge specific information about the individuals who have confirmed or suspected COVID-19, unless they are your family member and you have the necessary permissions to receive such information. We know you are concerned about your loved one, but it is crucial that we restrict visitation to reduce the spread of this virus to others. We will contact you directly if your loved one is suspected or diagnosed with COVID-19.

We also understand that connecting with family members is incredibly important to our residents. Additionally, we encourage family members to connect with their loved ones through video chat, calling or facetime. We can also arrange for window visits.
