To Our Residents and Family Members:

In our ongoing communication with you during the COVID-19 pandemic, **Maple Grove Nursing and Rehab** continues to issue communication regarding the status of our residents and employees. On August 28, 2021, we received confirmation that one employee tested positive for COVID-19. This employee has been removed from work and will be self-quarantining. Prior to returning to work, a negative PCR test will be required. **Maple Grove Nursing and Rehab** will be completing 100% testing over the next few days, and we will provide additional information as appropriate. **Our team at Maple Grove Nursing and Rehab remain committed to the quality and safe care of our residents and as a result are postponing all visitation until further notice. We will continue to provide updates as additional information becomes available.** 

The safety and wellbeing of our residents continues to be our top priority. We are doing everything we can to prevent the spread of COVID-19 within **Maple Grove Nursing and Rehab**, including staying in very close communication with local and state health officials to ensure we are taking all the appropriate steps under current circumstances.

We are taking steps based on guidance from the Centers for Disease Control and Prevention (CDC) and the Center for Medicare and Medicaid Services (CMS) to reduce the spread and impact of COVID-19, such as:

- Enhanced infection control precautions
- Screening residents, staff, and essential visitors for expanded list of symptoms
- Restricting visitation and entry of people to the building
